A LITTLE INFORMATION ABOUT OKTOBERFEST

Oktoberfest is a popular event held annually in La Veta, at the foot of the Spanish Peaks. There is no admission fee to the public. All kinds of food and merchandise booths are welcome, except for garage sale or flea market-type booths. In addition to vendor booths, there is live music, prizes, food and a beer garden. The event is held rain or shine.

RULES AND REGULATIONS

Spaces are assigned on a first-come, first-served basis, so mail your application early.

Please specify, in detail, the wares you will be selling at Oktoberfest (i.e., don't just say jewelry, say what type of jewelry, etc.). The Oktoberfest Committee strives to not place similar vendors adjacent to each other, but we cannot do so if we don't know what it is you're selling.

You **MUST** check in at Oktoberfest Central on Main Street (look for the signs) prior to setting up your booth. **DO NOT ASSUME YOU KNOW THE LOCATION OF YOUR BOOTH!**

Set up is from 6 - 8 a.m. All vehicles **MUST** be off the street by 8 a.m. No exceptions. Give yourself enough time to set up!

If you arrive late and cannot get your merchandise to your booth, you will **NOT** be assigned another space and **NO** refund will be given.

If you have a preference for a particular space, please let us know on your application. However, we cannot - and do not - guarantee that you will be assigned that space.

Electricity is **NOT** available and generators are prohibited. Food vendors with generators will be permitted only if permission is granted **IN ADVANCE**.

Spaces are 10 x 10. No exceptions. If you need a space larger than 10 x 10, you must reserve 2 spaces.

You must bring your own tables, chairs, etc.

The sale of alcohol is prohibited.

The sale of weapons (guns, knives or otherwise) is strictly prohibited.

The sale of exploding toys, silly string, poppers or offensive toys is prohibited.

ADDITIONAL RULES AND REGULATIONS FOR FOOD VENDORS

A copy of your Food Service license must accompany your application and fee.

No carnival rigs are permitted, except by special permission

Generators are not permitted, except by special permission. Permitted generators must be muffled.

Food vendors must be in their assigned space by 6:30 a.m. **NO EXCEPTIONS.** If you are late and cannot access your assigned space, you will **NOT** be assigned another space and **NO REFUND** will be given.

ALL VENDORS:

Sign and return page 3 with your application and check.

Keep pages 1 and 2 for your information.

I have read and understand the attached rules and regulations. I agree that if I do not comply with the Rules and Regulations as set forth by the Oktoberfest Committee, I may not be permitted to set up my booth and I will not receive a refund.
